Maintenance of Statutory Registers & Minute Books

Every Irish company is obliged to maintain a number of statutory registers and minute books in the State under the Companies Act 2014.

We maintain and update your statutory registers and keep them in order at all times and in the event of an inspection of a specific register, we will take full control of the request and inspection.

Registered Office Address Facility

The registered office address of an Irish company must be held in the State. RBK can provide a registered office address facility on your behalf on a short term or long term basis to suit your needs.

We will ensure that any correspondence received at the registered office address is actioned promptly or relayed to the relevant contact in your company.

Annual Returns

We prepare and file your annual returns on time ensuring that you are fully compliant with the requirements of the Companies Act 2014 and that your filing obligations with the Companies Registration Office is impeccable.

Meetings

Register of Beneficial Ownership

The European Union (Anti-Money Laundering: Beneficial Ownership of Corporate Entities) Regulations 2019 impose new and continuous obligations on companies to obtain, hold and maintain adequate, accurate and current information in respect of its beneficial owners at all times.

In addition, every relevant entity is required to submit particulars of its beneficial owners to the Central Register and any changes in its beneficial owners or their particulars within a certain time frame going forward.

RBK can advise and assist with your obligations to ensure you are fully compliant with the 2019 Regulations to include;

- Creation of the internal register of beneficial ownership
- Notice to a natural person believed to be a beneficial owner
- Notice to a person believed to have information concerning beneficial ownership
- Other steps to identify the beneficial owners
- Notice to a natural person to confirm occurrence of change
- Submission of beneficial ownership particulars to the Central Register
- Submission of a change in beneficial ownership or their particulars to the Central Register
- Maintenance of the register of beneficial ownership
